

To Whom It May Concern,

Chapter 15 State of Indiana for the North American National Party for The United States of America which operates within the metes and bounds and seaward boundaries of the States of the Union [LINK](#) hereby notifies



the Gibson County political subdivision of Indiana and all listed entities above, that Notices of Liability were delivered to Toyota Boshoku Indiana and Toyota Motor Manufacturing Indiana on Monday, July 25, 2022. Toyota Motor Manufacturing Indiana refused international process of service and notified the armed Foreign Registered Agent, hereinafter "Sheriff," of Gibson County political subdivision of Indiana. The armed Foreign Registered Agent came to the venue, interrogated the North American National Party member, hereinafter "Brandon Scott Gibbs," and tried forced association and trafficking in person by writing a ticket.

Furthermore, the armed Foreign Registered Agent stole the tangible private property of BRANDON SCOTT GIBBS, PMA which is considered trespassing into a Private Membership Association held by a Trust.

Armed Foreign Registered Agents have committed a violation of Article 34 of the Bi-Lateral Social Compact Agreement by and between the people for the States of the Union of The United States of America, evidenced herein; (Article 34) "The people for The United States of America agree that Communism in all of its forms are hereby outlawed within the metes and bounds and seaward boundaries of The United States of America" [LINK](#).

Furthermore, the armed Foreign Registered Agents attempted to administer corporate policies within the foreign political subdivision of the paper "State of Indiana", [LINK](#), arbitrarily within the original State of Indiana absent a legally written, signed, and published Social Compact by and between a permanent population of a State authorizing administration of executive, legislative and judicial body politics. Foreign Registered Agents have no standing vacant an Article VI oath of the United States Constitution also evidenced within 4 U.S. Code § 101, arbitrarily representing a vacant office to enforce or dispense justice outside of the District of Columbia, and act only as a service company for affiliates, and for hire, not a State.

These actions were recorded and will be used as evidence in the Human Rights Tribunal as the armed Foreign Registered Agents committed violation of Public Laws 101 [LINK](#):

- Theft
- Trespassing
- Forced association
- Slavery, by trafficking in person
- and Communism.



The tangible private property of BRANDON SCOTT GIBBS, PMA must be returned free of charges within forty-eight hours (48) from the receipt of this notice.

An Affidavit of Fact for the Human Rights and War Crimes Tribunal has been prepared and will be published if no remedy is found. The Gibson County political subdivision of Indiana, armed Foreign Registered Agents will be liable for the robbery of the tangible private property of BRANDON SCOTT GIBBS, PMA.
