## NOTICE TO CEASE AND DESIST

To whom it may concern,

Chapter 10 State of Florida for the North American National Party [LINK](#) for The United States of America which operates within the metes and bounds and seaward boundaries of the States of the Union [LINK](#), hereby notifies PASCO COUNTY, a corporation listed as “County of Pasco” [LINK](#) within the political subdivision of Florida, a corporation listed on dun & bradstreet (listed under the parent corporation DUN & BRADSTREET HOLDINGS, INC. [LINK](#)) as “State of Florida” [LINK](#), for arbitrarily harassing the inhabitants within the metes and bounds and seaward boundaries of The United States of America by implementing “Predictive Policing” that appears as a method to harass and coerce with corporate policies, [LINK](#).

Chris Nocco, hereinafter “Foreign Registered Agent” operating under the label “Sheriff” of PASCO COUNTY within the political subdivision of Florida, is using drastic methods to go after the inhabitants within the metes and bounds and seaward boundaries of The United States of America in the attempt to prevent future crimes without those crimes being detected or executed. The “authority” given to the Foreign Registered Agents, Chris Nocco and his coworkers working for PASCO COUNTY within the political subdivision of Florida, **is considered null and void** by the absence of a government formed by a body politic. A Government body politic consists of a nation or state with citizens in social compact as a civil society. The Foreign Registered Agent is attempting to administer corporate policies within the foreign political subdivision of the paper “State of Florida” [LINK](#), arbitrarily within the States of the Union, and absent of a legally written, signed, and published Social Compact by and between a permanent population of a State authorizing administration of executive, legislative and judicial body politics. Foreign Registered Agents have no standing vacant an Article VI oath of the United States Constitution also evidenced within 4 U.S. Code § 101, arbitrarily representing a vacant office to enforce or dispense justice outside of the District of Columbia, and act only as a service company for affiliates, and for hire, not a State.
