Chapter 39 State of Pennsylvania for the North American National Party [LINK](#) for The United States of America which operates within the metes and bounds and seaward boundaries of the States of the Union [LINK](#), hereby notifies NORTHERN YORK COUNTY SCHOOL DISTRICT, a corporation listed as “Northern York County School District” [LINK](#), hereinafter “NYCSD,” within the political subdivision of Pennsylvania, a corporation listed on dun & bradstreet (listed under the parent corporation DUN & BRADSTREET HOLDINGS, INC. [LINK](#)) as “Commonwealth of Pennsylvania” [LINK](#), for aiding and abetting war criminals and an international terrorist group [LINK LINK](#)

Douglas Mesner, also known as Douglas Misicko, Key Principle of UNITED FEDERATION OF CHURCHES, LLC (listed on dun & bradstreet as “United Federation of Churches, LLC [LINK](#)), and doing business as Lucien Greaves, hereinafter “Greaves,” and The Satanic Temple, hereinafter “TST,” have committed nefarious acts including but not limited to advocating for, and claiming the religious rights to the satanic ritual of, child sacrifice in their “religious ceremonies,” and directing political attacks against facilities dedicated to religion, education, and other cultural aspects of society [LINK](#). Greaves and TST have been internationally, nationally, and publicly noticed as a cover for a pedophile ring for identifying as Satan worshippers and offering “little boy love” in multiple publications.
