EVENTS

1. State Coordinator for the North American National Party for the constitutional States of the Union of The United States of America Exhibit 1 page 5, Elisabeth Chalaca Odou, hereinafter “co-Representative”, and
2. Co-Representative recorded on (October 11th, 2022) at the clerk’s office of the Branch Courthouse located 3117 Overseas Highway- Marathon, Florida Exhibit 2 page 6 and 7 the notice of co-representation for ANTHONY REDLER, PMA hereinafter “victim” a registered member of the North American National Party for the constitutional States of the Union of The United States of America Exhibit 3 page 8, and



3. At about 9 am UTC-6 co-representative entered in the court room with victim to be heard by James Morgan, and
4. At about 11.30 am UTC-6 James Morgan asked if someone had a Motion to discuss. Co-representative stood up and express the discussion of MOTION TO DISMISS that was recorded on (October 4th, 2022) at the Clerk's office Exhibit 4 pages 9-10-11, and
5. James Morgan told co-representative that the MOTION TO DISMISS will be discussed shortly, and
6. Few minutes later James Morgan called the entity "Anthony Redler". Co-representative stood up and mentioned "are you calling for ANTHONY REDLER, PMA", and
7. James Morgan asked co-representative to identify. Co-representative answered "I am Elisabeth Chalaca Odou, Coordinator of the North American National Party for the constitutional States of the Union of The United States of America. I am here to co-represent ANTHONY REDLER, PMA. A MOTION TO DISMISS has been recorded on (October 4th, 2022) as well as victim's Affidavit of fact", and
8. James Morgan, started yelling at co-representative, threatening co-representative to get arrested for court contempt, and
9. Co-representative answered "I am Elisabeth Chalaca Odou, Coordinator of the North American National Party for the constitutional States of the Union of The United States of America. I am here to co-represent ANTHONY REDLER, PMA", and
10. James Morgan changed the way he addressed to co-representative by saying "Oh you are here to help with translation, I apologize, we are behind, and we will call you out in few minutes", and
11. Few minutes later, the court phone rung and a French interpreter was on the line, and
12. James Morgan refused that co-representative represent victim and called victim to the podium and,
13. Co-representative was trying to help victim with advice when three US district agents came into the court room, and
14. Few minutes later, one of the US district agents asked co-representative to leave the court room, and
15. Co-representative stayed in the court building hallway when two US district agents started asking co-representative introduction, and
16. Co-representative answered, "I am the Coordinator of the North American National Party for the constitutional States of the Union of The United States of America. I am here to co-represent ANTHONY REDLER, PMA", and
17. The two US district agents were not able to understand and asked co-representative to wait outside of the court building, and
18. Co-representative sat on a bench outside of the court building when the two US district agents came up and a third one joined, and
19. Co-representative was asked again to be identified which co-representative repeated again, 'I am the Coordinator of the North American National Party for the constitutional





MOTION TO DISMISS

I, Anthony Redler, hereinafter referred to as Defendant, hereby motions the court to dismiss case# 22CT762AM for the following just cause(s):

- 1: Defendant is being accused of a crime that does not legally exist.
2. Defendant is maintaining that there is no controversy before the court.
- 3: Defendant is being accused of driving without a driver's license that does not legally exist.

NARRATIVE

The defendant went to the Department of Motor Vehicles to obtain a driver's license. The Department of Motor Vehicles failed to produce a form that would grant the defendants intangible property to the use of the public highways to the Department of Motor Vehicles. The aforementioned grant would produce a valid contract of terms and conditions under the license

that the defendant would sign in order for the prosecution to prove intent to violate the statute that the defendant is being accused of knowingly, willfully and intentionally violating.

For with the aforementioned grant wherein the Department of Motor Vehicles would fill the position of grantee and the defendant would fulfill the position of grantor thereby forming a trust agreement by and between the grantor and grantee wherein a license would legally exist. For without the aforementioned trust agreement, a license cannot legally exist and therefore there cannot exist a controversy before the court.

Although the Department of Motor Vehicles may have an easement on the Public Highways for maintenance of the Public Highways, the easement would not allow the Department of Motor Vehicles to license privately owned intangible property without just compensation to the defendant.

If the State does not have the right to take private property without just compensation, it is legally impossible for a department of the same or different State to claim a right that does not exist.

Therefore, the defendant hereby motions the court to dismiss case# 22CT762AM for the prosecution failing to state a claim wherein relief can be granted.



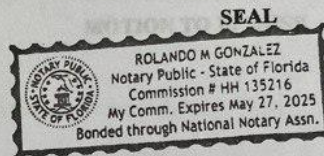

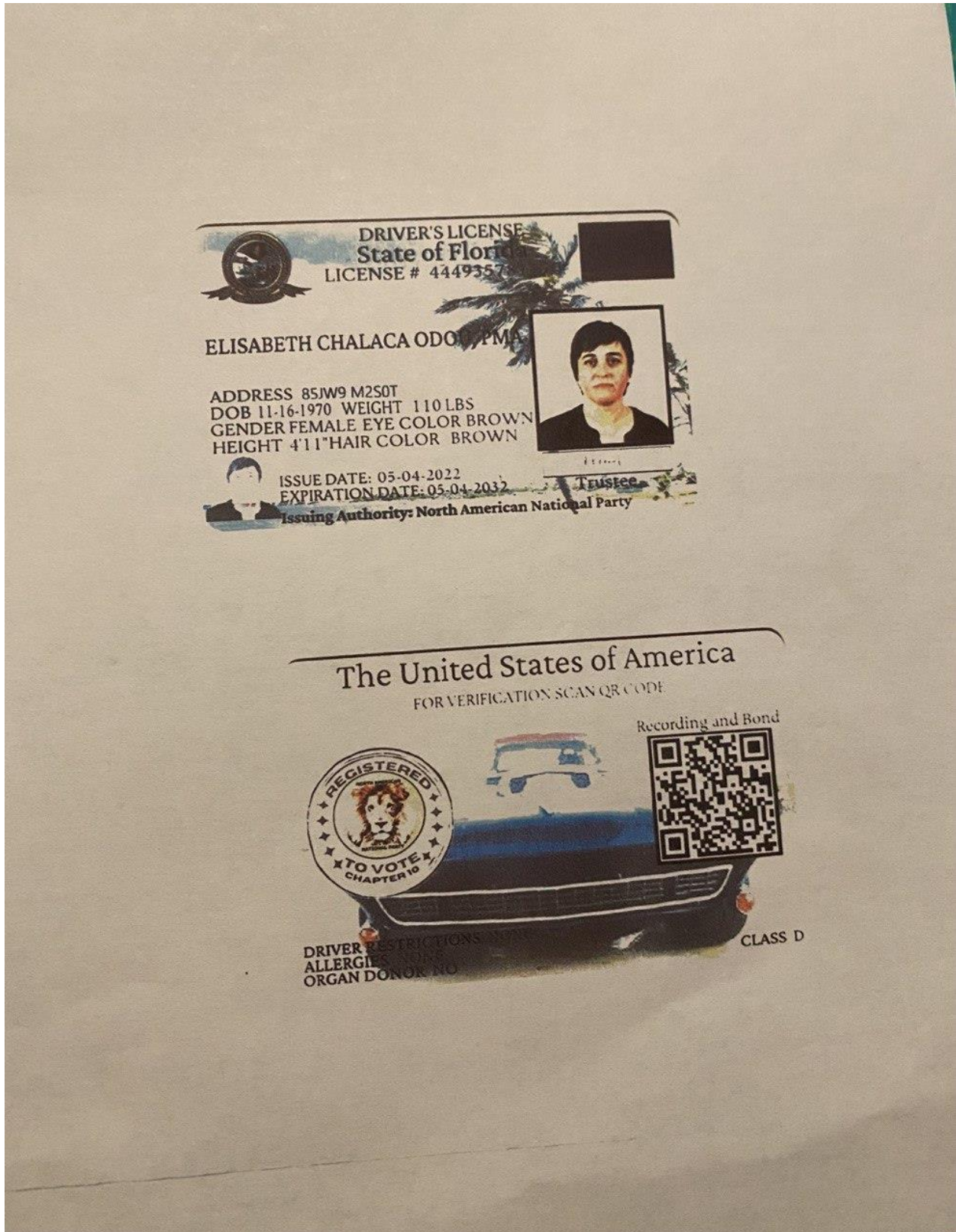
