NOTICE TO CEASE AND DESIST

To: All parties associating collectively in the Trafficking of ANTHONY REDLER's PERSON, or any other variation of the name, hereinafter "Member", into the adjunct County of Monroe (Exhibit 1, Page 3) within the Parent Corporation arbitrarily in the name of the constitutional State of Florida (Exhibit 2, Page 4), a political subdivision of United States corporation (Exhibit 3, Page 5 and 6), and

To the following persons herein; Florida Highway Patrol hereinafter "FHP" agents Brandee Williamson #3859, Jesus Gonzalez #5004, FHP County of Miami-Dade South and County of Monroe District Commander Captain Alvaro Feola, County of Monroe Sheriff Richard A. In the matter of ANTHONY REDLER, PMA, member of the North American National Party, hereinafter "NANP," for The United States of America (Exhibit 4 page 7), it is now recognized that agents for a division of the Florida Department of Highway Safety and Motor Vehicles (Exhibit 5, Page 8) have arbitrarily trafficked Member into the political subdivision of the State of Florida and the Internal Revenue Trust. Video evidence has been obtained regarding agents Jesus Gonzalez, #5004, and Brandee Williamson, #3859, for kidnapping, forced detainment,



and forced contracting approved by Richard A. Ramsay upon ANTHONY REDLER, PMA, held for ransom in the amount of negative three hundred seventy-three (-373) United States Dollars, hereinafter "USD." NANP is hereby warning all parties mentioned of the gravity of the political persecutions upon ANTHONY REDLER, PMA and is demanding all parties mentioned to **cease and desist any further actions upon Member immediately**. NANP hereby notices all parties mentioned that Member will not be present in parties' private venue going forward. All prosecutions in the future upon Member will be deferred to the public Human Rights Tribunal International of The United States of America or the General Post Master Council.

This notice is effective on the 221st day in the year of Yahweh 6024, translation date 26th of October, 2022.

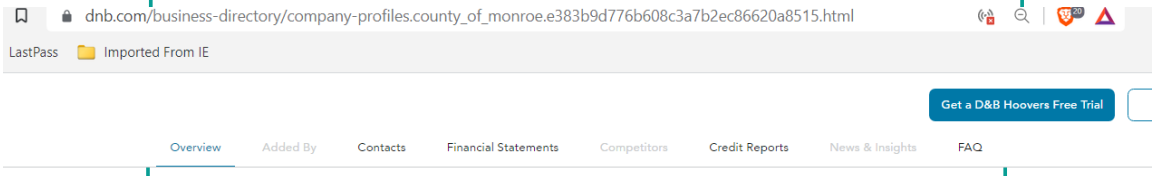
