On (December 8th, 2022), foreign political subdivision agent Justin Van Nuil (hereinafter "JVN"), ID No. 1661, operating with Michigan State Police Niles, agency number MI1105300 (hereinafter "MSPN"), an agency operating within the foreign political subdivision County of Cass (hereinafter "COC") also listed as a corporation on Dun and Bradstreet evidenced in Exhibit 1 within this Notice, within the foreign political subdivision state of Michigan or Michigan state (hereinafter "MICHIGAN") also listed as a corporation evidenced in Exhibit 2 within this Notice, issued a "State of Michigan Uniform Law Citation" under Incident No. 53-4179-22 and Ticket No. X4145779, affiliated with Driver's License Number J-525-469-188-526, near M51 and CRYSTAL SPRINGS within the Township of POKAGON TWP, Evidenced in Exhibit 3 within this Notice, to a variation of the name KIRK EDWIN JENSEN, PMA, (hereinafter "KEJ") for operating a moped without a license. JVN illegally misinterpreted identity and detained KEJ at Berrien County Sheriff's Department located within the foreign political subdivision County of Berrien (hereinafter "COB") also listed as a corporation on Dun and Bradstreet evidenced in Exhibit 4 within this Notice, at (919 Port St) in Saint Joseph within MICHIGAN, and



The “State of Michigan Uniform Law Citation” was nefariously placed in a coat pocket belonging to KEJ, who was improperly noticed by JVN. This trafficking incident occurred due to a previous international controversy regarding a citation numbered 610945 in 2019, with which “State of Michigan Uniform Law Citation” has been associated, Evidenced in Exhibit 5 within this Notice, and

KEJ is a member of North American National Party for The United States of America (hereinafter “NANP”), evidenced in Exhibit 6 within this Notice, and has claimed a nationality as one of a permanent population of the States of the Union of 1775 within the metes and bounds and seaward boundaries of The United States of America thereby claiming certain inalienable rights evidenced in Exhibit 6 within this Notice, and

Neither COC nor COB have any jurisdiction over any member of NANP within the constitutional States of the Union of 1775 within the metes and bounds and seaward boundaries of The United States of America. All arbitrary “authority” given to any one person but not limited to magistrates/judges, attorneys/esquires, officers/foreign registered agents/agents, and affiliates/subsidiaries of COC and COB operating within MICHIGAN to enforce communist corporate policies is **null and void** vacant a state government formed by a permanent population in written, signed, and published social compact authorizing the state’s body politics. A Government body politic consists of a nation or state with citizens in social compact as a civil society.
