The Montevideo Convention on the Rights and Duties of States

INTERNATIONAL AND NATIONAL PUBLIC NOTICE

Identified as: 20230104–NANP-IN

The Montevideo Convention on the Rights and Duties of States classifies a state as a person in international law, and sets out the definition, rights, and duties of statehood. The four criteria for statehood are; 1.) a permanent population, 2.) a defined territory, 3.) government, 4.) capacity to enter into relations with the other states, and are recognized internationally as an accurate declaration of customary international law. This principle of custom has been acknowledged, accepted, and is evident within the metes and bounds and seaward boundaries of The United States of America by way of treaties, decisions of national and international Tribunals, national legislation, opinions of national and international legal counsel, and diplomatic correspondence with international organizations.

North American National Party (hereinafter “NANP”) is the political party for The United States of America, wherein The United States of America is classified as a person in international law (*Law of Nations*), consisting of Declared residents and affirmed American Nationals. Further, The United States of America supports the statehood of the governing Body of people that grants full rights privilege of a Nationality, voting rights, and full control over the affairs within the original States of the Union of 1774. NANP upholds the Bilateral Social Compact Agreement by and between the people of The United States of America, its independent political affiliation, and the oath or affirmation required for statehood which serves as evidence of NANP’s permanent population to the metes and bounds and seaward boundaries of The United States of America.

NANP acknowledges that The United States of America has fulfilled all qualifications for statehood and is to be recognized by the Montevideo Convention on the Rights and Duties of States, and all entities therein.
