NOTICE OF TRESPASS/

NOTICE TO CEASE AND DESIST

To: Pottawattamie County Sheriff's Office Civil Division, Civil Division in Pottawattamie County, Iowa, Kimberly Kay Reynolds, Brian Shea, Pottawattamie County Treasurer, and BANK OF BENNINGTON/I3 bank and/or representatives.

On (January 23rd, 2023), Kevin Michael Juhas, Trustee (hereinafter "Trustee") of KEVIN MICHAEL JUHAS, PMA, (hereinafter "KMJ"), a member of North American National Party for The United States of America (hereinafter "NANP") evidenced in Exhibit 1, Page 4 within this Notice of Trespass/Notice to Cease And Desist (hereinafter "Notice") noted that an employee of Pottawattamie county within the political subdivision of Iowa (hereinafter "Deputy"), said county also listed as County of Pottawattamie, a corporation on Dun & Bradstreet within the political subdivision of Iowa, **trespassed** on KMJ's private property, a violation of Public Law 101-3, Public Law 101-9 and Public Law 101-12 (formerly known as Universal Declaration of Human Rights), evidenced in Exhibit 2, Page 5 and Exhibit 3, Page 6 within this Notice.

Trustee noticed that Deputy taped an envelope on the front door of KMJ's private property for "Kevin Juhas or Person/Persons in possession". Said person is not a member of KMJ, therefore said person and Deputy are not lawfully allowed on KMJ's private property. KMJ's private property located at Natural Area Code (NAC) number: 7089W PV9PG has been lawfully claimed within the metes and bounds and seaward boundaries of The United States of America evidenced in Exhibit 5, Page 8, Paragraph 1 within this Notice. KMJ's private property has clear signs posted with the verbiage "PMA MEMBERS ONLY", evidenced in Exhibit 5, Page 10 within this Notice.

Pottawattamie county (hereinafter "county") and the corporation County of Pottawattamie (hereinafter "County") **have NO JURIDICITION** over any member of NANP, evidenced in Exhibit 6, Page 14 within this Notice. All arbitrary "authority" given to any one employee, official, or officer of county/County including the "Sheriff" operating within the political subdivision of Iowa (hereinafter "state of Iowa") and State of Iowa corporation (hereinafter "Corporation")



evidenced in Exhibit 4, page 7 within this Notice, to enforce communist political and corporate policies is hereby **null and void** vacant a state government formed by and between a permanent population in written, signed, and published social compact authorizing the state's body politics. A Government body politic consists of a nation or state with citizens in social compact as a civil society. The Executive and Legislative officials, and Judicial officials and officers of state of Iowa and Corporation only have authority over inhabitants whose PERSONS have NOT claimed a Nationality within the States of the Union of 1774.

The territory state of Iowa is within the District of Columbia body corporate for municipality purposes per the District of Columbia Organic Act of 1871 and those persons or PERSONS operating for state of Iowa and Corporation are not within the metes and bounds of District of Columbia, therefore committing Infiltration of the original State of Iowa currently held in trust within the Government of The United States of America under the Northwest Ordinance. United States corporation in District of Columbia has only executive/corporate members with oaths between themselves, not between the populace, and have no government political authority to operate in legislative or judicial capacities, therefore all persons/PERSONS operating as elected legislative officials and judicial officers within United States corporation are in violation of the codified *Law of Nations Book I. 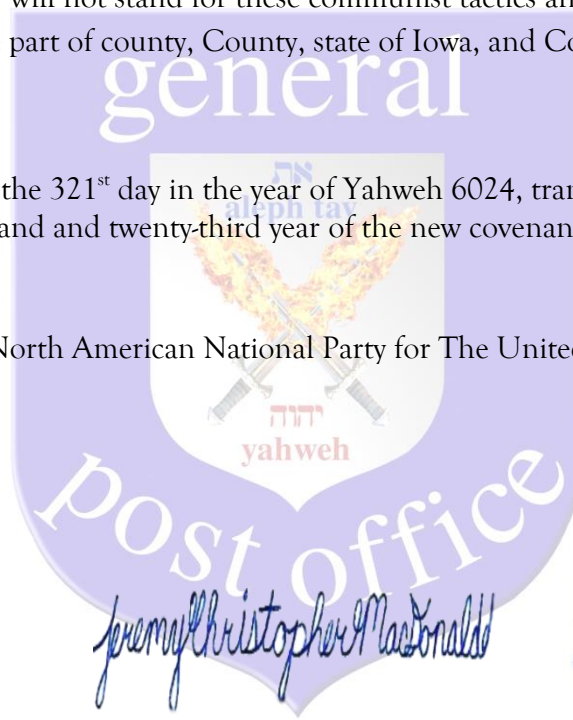
