Kinsey Institute For Research in Sex Gender And Reproduction, Bloomington Human Rights Commission, County of Monroe, and Monroe City Council have **ten (10) days** from (February 28th, 2023) to adhere to this Notice or face actions against Human Rights violations through the Human Rights Tribunal International.

This notice is effective on the 346th day in the year of Yahweh 6024, translation date 28th of February in the two thousand and twenty-third year of the new covenant in Yahushua's name.
